# 24. TREASURER'S REPORT FOR PRIORITY AND BUDGET SETTING 2019/20

The Treasurer took Members through the report and highlighted the following:

- An email had been sent to MFG Solicitors chasing the lease for the Civic Centre from Worcestershire County Council. Members asked for a letter to be sent to the Chief Executive asking for the lease to be completed as soon as possible.
- A meeting had been held with Linda Draycott at Wyre Forest District Council, regarding the Riverside paddling pool. She advised that the lease agreement had not been signed but the paddling pool had transferred to Stourport Town Council with 100% of the costs to be paid by the Town Council in 2019/20. However, Wyre Forest District Council would still provide the expertise and manpower to run the paddling pool. Members agreed that localism funding would be applied for next year to help run the paddling pool.

- Salaries for all parks staff had been bought into line with NJC pay scales.
- Members agreed to increase 'headline' fee for the cemetery from £700 to £720 with effect from 1st April 2019 and allotment rents would increase from £40 to £44 for a full plot and from £20 to £22 for a small plot. It was noted that there had not been an increase in allotment rents for 4 years.
- There was a budget for replacement computers but it was perceived that this was quite high and some of the money would be allocated for the restoration work of the WWI memorial in the town gardens, for which quotes were awaited.
- The Council van would only be replaced if necessary.

### 25. SIGNAGE AT WAR MEMORIAL PARK

Members approved an additional £5,000 to the parks budget for new signage in the Memorial Park.

The treasurer was thanked for his informative report.

The meeting was closed at 3.35pm.
